







# KNOWING YOUR HORIZON CAMERA



# DESKTOP CHARGING




- 1. Attach the USB adapter to the camera, make sure it clicks into place.
- 2. Once connected, plug the mini USB end of the power/data cable into the adapter and plug the standard USB connector into your computer for charging.
- 3. Connect the USB adapter to the camera and connect the power/data cable to charge it.

The Waylens camera is the high-performance piece of equipment and should be handled with care.

# INSTALLING THE WINDSHIELD MOUNT AND POWER CABLE



 Once you've identified a safe and proper location for the camera, make sure the windshield is clean and residue-free.

Note: Make sure the camera does not block your view of the road.

- Remove the protective film from the windshield mount and adhere to the windshield.
- 3. Secure the camera to the mount by aligning the 5-pin contacts on the camera to the 5-pin connection on the mount and press them together.
- Once the camera is attached to the mount properly, align the camera for the proper viewing angle and tighten the locking wheel counter-clockwise to secure.
- Install the car charger (12v negative ground only) and route the 13' power cable to the camera mount with the provided cable clips.

# INSTALLING THE DATA MODULE (OBD II)





Plug the Horizon Data Module into the OBD port in your vehicle.

Note: most vehicles 1996 and newer have this





Your system comes with a remote control to provide a safe way to highlight moments of interest.

Attach it to your steering wheel using the supplied strap and remove plastic tab.





You may also remove it from the strap and affix it to any clean surface using the supplied double-sided tape.
